Square and Round Dance Federation of Nova Scotia President's Report

The past year has been one of disappointments, challenges, some successes and celebrations.

As an organization we continue to be challenged on marketing our dance activities with the goal of increasing our numbers. While nationally the number of insured dancers fell by approximately 3 percent, regrettably, Nova Scotia recorded an approximate 11 percent reduction in insured dancers. Recruiting and retention of dancers continues to be our greatest challenge.

Some of our clubs continue to retain or increase their numbers, while others continue on a downward spiral. This year there was not enough dancers for Sunrise Squares Dancers to continue even monthly dances. The South Shore presently has only one active club (LaHave River Ramblers) and it is operating on a quarterly basis. LaHave River Ramblers were featured in a full page article in a recent "South Shore Breaker". Other clubs continue to struggle to remain open.

Our Contra clubs continue to retain their numbers and the addition of a new Contra group in the Valley is welcome. It is noted Contra generally draws a younger demographic.

Over the past year we were privileged to attend and participate in dancer graduations and recognition awards, the most recent being the Centurion Award presented to Esther Chute on behalf of the United Squares Dancers of America.

The local and national media attention given to this was indeed welcome, and hopefully will raise a greater awareness to square dancing.

We were also privileged to participate in the CSRDS Publicity Round Table.

There was a lot of enthusiasm and good marketing ideas discussed which resulted in the formation of a national committee chaired by Cathy Langille. While it has been slow moving forward, the goal is still to develop a national marketing campaign.

SQUARE AND ROUND DANCE FEDERATION OF NOVA SCOTIA MARKETING REPORT 2013-14

The highlight of this year for marketing is the media coverage—both in print and TV—of Esther Chute's Centurian Award presented by the United Square Dancers of America. It was most rewarding to have one our own showcased on national TV.

This was followed by an item from New Brunswick's Elm Tree Square Dancers on CBC (Atlantic) on Thursday, 16 October, featuring their 2 young dancers.

The work of marketing cannot be achieved by complacency. Marketing has to be active and constant—given our aging membership, we cannot rely on human resources and must look to other methods of promoting square dancing as a safe,

healthy activity that is especially beneficial to the aging. Given recent promo from New Brunswick though, perhaps there is interest at the other end of the spectrum—10 to 12 year olds so we need to get our message to them.

Various methods of promoting square dancing have been explored, these include: brochures, rack cards, print media via community publications, local parks and rec. calendars, special events promotion, participation in public events such as 50+ Expo, health and wellness fairs, community parades, radio and television PSAs; social media and web sites. Each offers marketing value, but it is imperative we invest in the media that will yield the best effort toward increasing our membership.

Following is recommended annual expenditures for marketing:

Print Media-community publications Province-wide twice annually	\$1,500.00
General printing – brochures/rack cards	\$1,500.00
Participation in public events Health and wellness fairs throughout the Province whenever known and practical	\$1,000.00
Increase presence on the web and social media	\$ 500.00

The investment in portable signage has garnered favorable comments whenever they've been used, but they need to be used more frequently, including at our own major dances; i.e. festivals, MCCA, and suggest another one or two be acquired.

Glavine, Health & Wellness Minister and to Kathie NeuOrgan Show Manager of the 50 + Expo express my displeasure on behalf of the dancers. I witnessed other people that took extra time to promote their thing and yet nothing was said to them. I felt there was a double standard this year and the Square & Round Dance Federation of Nova Scotia paid the \$275.00 plus tax to participate for the two days.

The Annual General Meeting of the Society was held on July 18, 2014 in Ottawa.

The total Society membership for 2013-14 was 10,362. A decline of under 6%.

The membership in NS was: 1 Fed., 4 Assoc., 27 clubs, 460 dancers, Total 492.

The membership fee for 2014-2016 is unchanged.

The Articles of Continuance and the general operating By-laws under the Not For Profit Corporations Act, were approved. (Subsequently they were approved by Corporations Canada).

A motion to establish a system whereby new dancers are covered by the Society Liability Insurance for the period September to December 31, but not applying to snowbirds and dancers who have been members within the last 5 years, was approved.

A Publicity Round Table discussion was held during Festival 2014. Various suggestions for:

- Promotion and Recruitment;
- Getting money for recruitment;
- Retention of dancers; and
- Special problems within the activity were reviewed.

Volunteers were recruited to form a Society "Publicity Group" with representatives from each province. The group will attempt to develop plans to promote and advertise our activity across Canada.

As the elected representative for the Square and Round Dance Federation of Nova Scotia, I have also been elected to the Board of Directors of Dance Nova Scotia for a further two years.

Major projects I am working on include the development of Dance Nova Scotia's Governance framework in consultation with Strategic Arts Management agents; led the HR Committee for the hiring of staff and for contract services and resulting in establishing a staffing model for continuing use, and presented a travel policy for Board approval and subsequent adoption.

Dance Nova Scotia is currently under management of Cliff LeJeune, Interim Executive Director, whose term will conclude 1 June 2015 with the anticipated return of Megan Matheson-Hamilton who is presently on maternity leave.

One of Cliff's priorities is increasing the value of membership in Dance Nova Scotia. DANS is also working on its database using SUMAC which will include electronic membership renewals.

DANS Revue and weekly newsletter continues to be under utilized. The square, round and contra clubs are encouraged to submit articles, preferably with pictures, for publication. By virtue of membership in DANS, this is free promotion for our activities through both paper and electronic media.
