## President's Annual Report

November 2014 to October 2015

I begin by thanking everyone who has volunteered to serve with SRDFNS, and for their individual and collective efforts to promote and support our dance forms. Your hard work ensures the essential tasks required to organize and carry out the day-to-day operation of SRDFNS occurs. I'm sure you'll join me in a special word of appreciation to our Webmaster, Gary Welch, who has spent an enormous amount of time learning the nuances and technicalities of implementing our newly-imaged website and its compatibility with phones and tablets.

Nova Scotia continues to experience declining numbers with limited success in the recruitment and retention of new dancers. Some Regions are recruiting new dancers in sufficient numbers to keep their clubs solvent, while others continue to decline. On the positive side, Cumberland Twirlers continues to grow.

While the national average decline of dancers is around 3 percent annually, the decline in Nova Scotia is closer to 9 percent. Nova Scotia leads the way in percentage of its population over 60 in Canada. (StatsCan 2014), presenting us with an even greater challenge in the promotion of square and round dancing.

Contra is emerging as a dance choice of young adults; however, by its format, we are not gaining the membership of individual dancers, only the Contra clubs, their prompters and some dancers; therefore our numbers do not truly reflect contra dancers.

Many of our major dances and this year's Nova Scotia Festival dance, experienced significant reductions in attendance to a point where the event just breaks even or is operating at a loss. Our marketing and promotional initiatives have included community newspapers, digital advertising, PSA's and distribution of brochures and rack cards. Indications are that our message is getting out; however, we have very little in the way of new dancers to show for our work.

We continue to review our Marketing strategies and promotional methods, but to date, little is working and dancer retention is poor. This year saw major disappointments with the expulsion of SRDFNS from 50+expo, and our inability to perform at the Hank Snow Tribute in August; two events which attract the target market for our activity were lost.

SRDFNS has entered into partnerships where links are established on partner sites and our site. This is a no-cost way to expand our visibility and we are looking to expand this in the future.

Our Contra Dance community continues to expand with a new club developing in the Wolfville area. The Centennial Tour of CDSS (County Dance and Song Society) chose Nova Scotia as one of their stops. Our Contra Dance community was very busy over the past two years preparing for Contra Fest which took place from September 27 to October 3, 2015. By all accounts it was a successful festival.

We continue to streamline our communications and at this point, our Calendar of Events and special dance notices are emailed directly to all who want this form of communication.

Our database is up and running and as time permits, additional features and functions are added.

Nine Callers (2 from PEI, 1 from NB, 4 from NS) attended the Alguire Memorial Caller School August 16-21, 2015, held at Elm River RV Campground, Masstown, NS. Two Caller-Instructors, Dottie Welch and Kerry Fletcher, developed and instructed the week long school. A 2-day Cuer's Workshop was held in nearby Onslow. Each group held reciprocating closing dances providing students the opportunity to demonstrate their newly honed calling/cuing skills.

It is regrettable there has not been an increase in membership and I'm leaving with fewer active clubs than when I became President. I believe the main work of the Federation should be focused on recruitment and retention of dancers; to develop and promote through social media; and support recruitment and training callers where needed.

Following is the goal of the newly-formed CSRDS Marketing Committee proposed by the Co-Chairs Rachelle Cournoyer and Claudia Littlefair:

Square dancing is an activity popular with senior citizens that keeps them both healthy and mentally alert. There is a need to revitalize the dance form and to promote it to a new generation. The co-chairs propose to do the following during the next year: revitalize the web site, set up a national clearing house on good publicity ideas to share with square dancing clubs across the country, and to develop and form expertise in the use of social media for square dancing clubs across the country.

I will remain as a field contact with the CSRDS Marketing Committee for SRDFNS and will share with you any information that should come my way.

## Marketing Annual Report November 2014 to October 2015

### Accomplishments:

A rack card was created and distributed for review by the Board members and was generally concurred for print quantity of 1000. It was suggested Regional Representatives start by placing the rack cards in libraries throughout their region and other places at their discretion. I have not been asked for a resupply of the rack cards by the Regional Reps.

An additional retractable banner featuring the skirt/trousers/shoes is available for use at various events. Two such banners are now available for loan -- the other features the front of the general and teaching brochures. To date, I have not been asked for these banners to be borrowed.

### **Educational Opportunities:**

While attending the US National Square Dance Convention in Springfield, MA, June 24-27, we attended as many Marketing Seminars as possible and following is what we learned:

- It was apparent the whole activity of square dancing is in crisis and in most places, attracting enough dancers to replace the annual losses in membership is simply not happening.
- The whole business of promoting, recruiting and retaining dancers has not been given the attention required over the decades.
- The "Live Lively" campaign is still very much in its infancy and is unlikely to have much impact any time soon. Fundraising is consuming much of the organizers' time.
- The resources -- human and/or financial -- are not in sufficient supply for marketing campaigns or even demonstrations.
- There is an increasing reliance on social media and other technological means (u-tube, videos) to market our dances. Not only is this the "trend", it is essential to any marketing campaign.
- Fact: New dancers are most attracted to clubs with dancers 10 years younger or 10 years older than themselves. This is something to think about when recruiting younger dancers to a club with a median age of 78.

In short, the seminars were less than inspiring.

Although the need is critical, a marketing program to increase our member dancers is a long-term challenge -- not something that can immediately be picked up and expect to change in a couple of years.

### **Disappointments:**

The expulsion of SRDFNS from 50+expo and the failure to perform at the Hank Snow Tribute were two important opportunities to publicly display our dance forms and are major losses from a marketing perspective.

The appearance that the 50+expo event organizer and Dance Nova Scotia was in collaboration to eliminate square and round dancing presentations lead to my resignation from the Board of Directors of Dance Nova Scotia and also as the SRDFNS' representative to DANS.

In addition, due to lack of available caller and/or dancers, I have declined all other invitations to demo square dancing on the South Shore.

Another disappointment lies within the SRDFNS organization in the failure to include Marketing with major events; i.e. Festival 2015 in Wolfville. Nobody knew we were even at Old Orchard Inn because the media (local community paper, Community Links Rep., TV) had not been made aware such an event was taking place on their doorstep.

Mahone Bay Centre dances of August 29 and September 26 also turned out to be dismal failures in terms of attendance. The result is only enough revenue was generated to pay MBC for the room rental while Callers' fees are outstanding to be paid from the Marketing budget.

#### Encouragements:

At the invitation of Fundy Squares' Executive, we attended their AGM on September 23, 2015, specifically to address some marketing strategies they could pursue and advise them of the tools we currently have available to assist in their communication play; i.e. banners, rack cards, brochures, pins for graduates; as well as a funding grant.

Contra may have benefitted from the Mahone Bay Dance by gaining a young university student who was looking for an activity such as Contra in the city.

To conclude this report, I would thank the Board for its support.

## News from the Canadian Square and Round Dance Society (CSRDS)

The Nova Scotia Directors to the CSRDS, Bob and Inge Ruohoniemi, attended the Society's 1015 Annual General Meeting(AGM) in Lacombe, Alberta from 4 to 7 September. The meetings were hosted by the Alberta Federation at the Alberta Annual Convention.

The President, Eric McCormack, reported that the Society had received approval of the Transition and By-laws, approved at AGM14, to comply with the Corporations Canada Not for Profit (NPF) Act. CSRDS has become an Auxiliary Member of the Alliance of Round, Traditional, and Square Dance. The CSRDS Convention Guidelines and associated information have been revised to reflect current membership numbers and available venue arrangements. The South Western Ontario Square Dance Association submitted a bid to host the 20<sup>th</sup> National Convention in London, ON, in 2018. (Post meeting the Convention Letter of Agreement was signed).

The Past President, Bob Ruohoniemi, presented the revised Society Rules and Regulations to conform with the NPF Act to the meeting for approval. They were approved. He also reported that the letter requesting provincial nominations to the Society Board for 2016-2018, would be sent to the Provinces by 30 September. (Post meeting this has been done).

It was reported that the Society provided funding for One Square Dance Caller School and one Contra Caller School. Bursaries were provided to seven Callers.

The Society Award of Excellence was presented to Norm and Loretta Demeule, Alberta CSRDS Directors.

The Society website <u>www.squaredance.ca</u> has been updated and members are invited to visit it, for the latest Society information including the Minutes of AGM15. The Toll Free telephone line continues to be available at **866-206-6696**. Messages may be left on the answering machine.

It was reported that Society membership declined by 3.5% to 9,984; the smallest overall attrition in six years.
