a) Japanese Fund – Bob R. reported regarding the appeal to support Japanese Square Dancers who were victims of the Earthquake and Tsunami in March 2011. Donations were received from 7 dancers/couples, 20 clubs, 1 association, 1 federation, CSRDS. Total amount \$4,200. Expenses were paid by CSRDS and the Nova Scotia Federation. That amount was forwarded by the Bank of Montreal to the bank account of the "Nihon Square Dance Kyokai" or Japan Square Dance Association in Tokyo. Two letters of thanks from Japan received by Bob from Tatsuzo Takase, President JSDA, and from Keiji Handa, Executive Director JSDA.
