Net decrease in total of both accounts (Finance and Operating) during 2013-2014 fiscal

year was from \$53,375.26 to \$52,584.46 = \$790.80

Capital Investment Note: The By-Laws say "The Finance Committee shall use the fund of money initially turned over to the Federation by the Convention 1982 and 1994 Boards and any additional funds accumulated to make wise investments with good security in order to produce income from this fund." After some research, we agreed that \$40,000 should be our base figure for capital investment. Any other use of that capital investment requires a notice of a special resolution to be discussed and voted upon at a general meeting.

Archives: Still looking for a storage place in the central area for 4 big tote boxes. Cathy also has a box of old American Square Dance magazines. (coming to DW).

Webmaster and Website:

Gary continues to update the Calendar of Events, the collection of dance posters, and We Remember, and to make other minor changes as circumstances require.

Phantom Number 8 hit the air in May. Awaiting material for the next issue.

Since August the SRDFNS home page has featured a link to the home page of ContraFest 2015 – a week in Halifax next September of dancing, school visits and leader workshops intended to energize the contra dance scene in Nova Scotia. Gary is webmaster for the ContraFest 2015 site.

The SRDFNS Executive page now links to the new Executive Guidebook, as revised in March 2014. Changes in the Guidebook have been propagated to relevant locations elsewhere in the SRDFNS site, most obviously in the Federation Guidelines, Forms, and Awards pages.

We still have club histories to update.

Still working on back issues of the ANSSRDT Newsletter and Metro Matters.

Communications: The Calendar of Events has gone out for October with notice of the AGM and reminder about the Maritime Convention.

Format for Club Roster lists is very workable.

The CSRDS has indicated the intention to assign individuals an unchanging number. Deadline is November 15th for sending in Registration and Fees. New attendees will be able to be added by sending more fees and names to Ralph.

Marketing: Cathy and Paul Langille (See report e-mailed by Cathy)

Note the marketing highlight about Esther Chute's Centenarian Award which became a National news item. A Google search for Esther Chute will point to several photos, articles and the news videos.

Russ sent PSAs about Stardusters out after the Esther Chute publicity. Had several calls but only actually saw one dancer out at a dance. This year they have a returning family.

The new portable signage has been used at 50+Expo as an easy way to advertise.

DANS is working on Dance for Health directed toward the Seniors.

Transcontinental Media -- one shot of publicity through Transcontinental Media goes to all areas in Nova Scotia.

In the banking industry, they consider a successful campaign if they put out 1000 brochures, get 10 phone calls and that gives 1 person.

The \$460 ad in the Chronicle Herald in August generated at least 6 calls to British Columbia.

50+ Expo: Carol and Don Scott absent (See report e-mailed by Carol)

It was a frustrating experience on Saturday because they were discouraged from making noise several times, and someone else monopolized the available demonstration time.

There seems to be a new director every couple of years and information about our needs are rarely passed along.
